Scope and Content Note

The materials in FOIA 22-16623-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 22-16623-F requested all photos and videos of Facebook CEO Mark Zuckerberg.

This FOIA primarily contains photographs of President Obama participating in a town hall meeting moderated by Mark Zuckerberg in Palo Alto, California, on April 20, 2011; President Obama delivering remarks, participating in a discussion with entrepreneurs, and taking part in a Facebook Live taping during the Global Economic Summit in Stanford, California, on June 24, 2016; Mark Zuckerberg raising a question to President Obama and the panel during the CEO Summit of the Americas in Panama City, Panama, on April 10, 2015; the State Dinner for President Xi Jinping of China at the White House on September 25, 2015; President Obama holding a meeting with Internet CEOs to discuss privacy issues in the Oval Office on March 21, 2014; and President Obama talking with Mark Zuckerberg, Elliot Schrage, and Susan E. Rice, backstage prior to the Young Leaders of the Americas Initiative (YLAI) town hall in Lima, Peru, on November 19, 2016. Audiovisual records proposed for opening includes video footage from the remarks and discussion with entrepreneurs at the Global Economic Summit in Stanford, California, on June 24, 2016.

### System of Arrangement

The materials in FOIA 22-16623-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records and White House Communications Agency.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
