## **Scope and Content Note**

The materials in FOIA 22-16582-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 22-16582-F requested all photos with the actor George Clooney.

This FOIA primarily contains photographs of George Clooney visiting the White House to discuss the situation in Sudan with President Obama. There are also photographs of the filmmakers of "The Monuments Men" at the White House for a movie screening on February 18, 2014; President Obama and First Lady Michelle Obama hosting a United Kingdom State Dinner on March 14, 2012; President Obama playing basketball at Cheviot Hills Recreation Center in Los Angeles, California, on May 11, 2012; and President Obama delivering remarks during a Call to Action CEO roundtable and participating in the Leaders Summit on Refugees, both at the United Nations in New York on September 20, 2016.

## **System of Arrangement**

The materials in FOIA 22-16582-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas –Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
