FOIA 22-16600-F requested photographs of Jeff Bezos.

This FOIA primarily contains photographs of President Obama having lunch with CEOs in the Oval Office Private Dining Room on October 8, 2009. There are also photographs of First Lady Michelle Obama and Dr. Jill Biden hosting an event announcing commitments from more than 50 companies that have pledged to hire and train veterans and military spouses in the State Dining Room; President Obama meeting with Jeff Bezos and Jay Carney in the Oval Office; and President Obama and Jeff Bezos talking with recipients of the Presidential Early Career Award for Scientists and Engineers (PECASE) in the East Room, all on May 5, 2016

#### System of Arrangement

The materials in FOIA 22-16600-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
