FOIA 22-52088-F requested photographs of the June 4, 2010 Oval Office meeting between President Obama and Arizona Governor Jan Brewer.

This FOIA primarily contains photographs of that meeting between President Obama and Governor Brewer. Other participants included Joseph Kanefield, General Counsel for Governor Brewer; Brian McNeil, Deputy Chief of Staff for Governor Brewer; Kim Sabow, Deputy Director of Communications for Governor Brewer; John Brennan, Assistant to the President for Homeland Security and Counterterrorism; Bob Bauer, Counsel to the President; Cecilia Munoz, Director of Intergovernmental Affairs; Luis Miranda, Director of Hispanic Media; and Valerie Jarrett, Senior Advisor.

System of Arrangement

The materials in FOIA 22-52088-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Records responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
