### **Scope and Content Note**

The materials in FOIA 23-05306-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 23-05306-F requested materials related to documents from the White House Office of Counsel to President Obama about Jennifer Choe Groves.

This FOIA primarily contains nomination files related to Jennifer Choe Groves and nine other July 2015 Presidential Appointees, which includes email printouts, nomination and resignation letters, resumes, appointee record summaries, and news articles.

### **System of Arrangement**

The materials in FOIA 23-05306-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – White House Office of Records Management (WHORM) Subject Files.

The WHORM Alpha File was compiled by the White House Office of Records Management and is a series of documents arranged by name of persons, organizations, or events.

The WHORM Subject File was compiled by the White House Office of Records Management and consists of a series of documents assigned a letter/number combination and filed in a subject category. A complete listing of the subject categories including a detailed description of each category is available [on the National Archives Catalog](#).

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama

administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
