The materials in FOIA 22-30041-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 22-30041-F requested photographs of President Obama and other government officials meeting with the family members of the Benghazi attack victims at Joint Base Andrews on September 14, 2012.

This FOIA primarily contains photographs of President Obama meeting with the families; delivering remarks; and attending the dignified transfer of J. Christopher Stevens, U.S. Ambassador to Libya, Sean Smith, Information Management Officer, and Security Personnel Glen Doherty and Tyrone Woods. There are also photographs of Secretary of State Hillary Rodham Clinton delivering remarks.

# **System of Arrangement**

The materials in FOIA 22-30041-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
