FOIA 22-26840-F.2 requested records sent from National Security Advisor Susan Rice to any intelligence community member related to the alleged hacking of computer systems utilized by the Democratic National Committee and/or Clinton presidential campaign records from January 1, 2016 to January 20, 2017.

This FOIA primarily contains emails sent to or from Susan Rice related to the alleged hacking of the Democratic National Committee and the Clinton presidential campaign. All of the material proposed for opening is unclassified.

System of Arrangement

The materials in FOIA 22-26841-F.2 are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – National Security Council - Classified Electronic Records

Classified Obama Presidential Electronic Records are a unique segment preserved in an electronic system separate from the Electronic Records Archive (ERA). The records are processed by topic, printed, and filed in folders. Folders are arranged by data set and thereunder by date.

Classified Obama Presidential Electronic Records contain electronic records created or received by members of the White House staff, as well as the Commission on Weapons of Mass Destruction. These frequently classified records document the daily constitutional and statutory duties carried out by the Obama administration and include record types such as email, email attachments, Night Notes, and cables.
