The materials in FOIA 22-46223-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 22-46223-F requested all photographs of President Obama's visits with the Director of National Intelligence and at the National Counterterrorism Center on April 24, 2015, and December 17, 2015.

This FOIA primarily contains photographs of President Obama delivering remarks marking the 10th anniversary of ODNI at the Office of the Director of National Intelligence in McLean, Virginia on April 24, 2015; President Obama and Vice President Biden participating in a counterterrorism threat briefing; and President Barack Obama delivering remarks to NCTC staff at the National Counterterrorism Center in McLean, Virginia, both on December 17, 2015.

System of Arrangement

The materials in FOIA 22-46223-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
