FOIA 22-64502-F requested all photos held by the Barack Obama Presidential Library of the actor Sidney Poitier.

This FOIA primarily contains photographs of President Barack Obama and First Lady Michelle Obama at the Gala for Re-Opening of Ford's Theater in Washington, DC, with Sidney Poitier and George Lucas on February 11, 2009; and the 2009 Medal of Freedom Ceremony at the White House on August 12, 2009, where Sidney Poitier was one of the Medal of Freedom recipients.

#### System of Arrangement

The materials in FOIA 22-64502-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
