Scope and Content Note

The materials in FOIA 22-16573-F.3 are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 22-16573-F.3 requested all photos and videos from White House and Camp David movie screenings. All photos were previously released in segment 1.

This FOIA primarily contains footage by the White House videographer at the screening of the film “Red Tails” at the White House on January 13, 2012, and the screening of the film “Lincoln” at the White House on November 15, 2012.

### System of Arrangement

The materials in FOIA 22-16573-F.3 are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – White House Communications Agency.

White House Communications Agency records are processed at the folder/videotape level. While this method maintains folder/videotape integrity, it frequently results in the incidental processing of videotapes that are not wholly responsive to the subject area.
