Scope and Content Note

The materials in FOIA 24-01184-F are a selective, not necessarily all-inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

FOIA 24-01184-F requested photographs from President Obama's visit to New York following Hurricane Sandy on November 15, 2012 - particularly photos from Staten Island.

This FOIA primarily contains photographs of President Obama taking an aerial tour aboard Marine One and a walking tour to view storm damage from Hurricane Sandy; talking with residents on Cedar Grove Avenue during a walking tour; meeting with local officials, first responders, FEMA staff and families recovering from Hurricane Sandy, at a local FEMA Disaster Recovery Center; and delivering a statement to the press, all in Staten Island.

System of Arrangement

The materials in FOIA 24-01184-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
