FOIA 22-22178-F requested materials related to documents from the Obama administration comparing the covert operation to capture/kill Osama bin Laden and the failed attempt, Operation Eagle Claw, to rescue

Americans during the Iranian hostage crisis on April 24-25, 1980 during the Carter administration.

This FOIA primarily contains news clip digests and email correspondence containing new articles about Operation Neptune's Spear and Operation Eagle Claw.

System of Arrangement

The materials in FOIA 22-22178-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas – Obama Presidential Electronic Records

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.
