FOIA 22-21403-F requested the detailed calendars or schedules of the former Deputy National Security Advisers for Homeland Security and Counterterrorism John O Brennan (from 1/20/2009 through 1/25/2013) and Lisa Monaco (from 1/25/2013 through 1/20/2017).

This FOIA primarily consists of outlook calendar appointments for John Brennan and Lisa Monaco.

## **System of Arrangement**

The materials in FOIA 22-21403-F are a systematic body of documents responsive to the topic of the FOIA. Researchers should consult an archivist about related materials.

Documents responsive to this FOIA were found in these collection areas - Obama Presidential Electronic Records.

The Executive Office of the President (EOP) instance of the Electronic Records Archive (ERA) contains electronic records created or received by Obama administration staff. These records are stored in Search and Access Sets (SAS) that represent their originating computer program, such as Exchange Email or the Worker and Visitor Entry System (WAVES). In addition to records captured from the White House's electronic systems, EOP-ERA also contains records from the home and shared drives used by White House staff.

### **Electronic Records**

Outlook Monaco contains 579 assets, of which 410 are released in full and 169 are withheld in full.

Outlook Brennan contains 446 assets, of which 218 are released in full and 228 are withheld in full.
