But with CFC, when staff donate to charity, we do not "advertise" per se who the eagles and double eagles (the more generous/big donors) are since financial donations are considered sort of private/personal/sensitive.

But if [redacted] asked you to, what are you supposed to say? I don't think it's a big deal, just in the future I would think twice and/or seek Cathy or Don's approval before sharing information about what a staff member donated to a charity or organization or anything along those lines.
