Back from the OVAL

After Vice President Biden and Attorney General Holder announced that the Recovery Act would award \$1 billion in grants to local law enforcement agencies, police departments in twenty-four states from North Dakota to Florida reported that they will be able to hire or retain police officers.

Five states announced that they would be able to save or create jobs due to stimulus funds, including Iowa where Hawkeye Community College planned to hire additional instructors. A report detailing jobs created and retained by the Recovery Act by state, found that Washington led the nation with 3,481 jobs created or saved so far.

In addition, one noteworthy story this week came out of Boulder, Colorado, where Blake Lewis, the president of Namaste Solar, the company visited by President Obama the day the Recovery Act was signed, lauded the success of the Recovery Act. Lewis, whose company is thriving under the Recovery Act, stated that the Act's "promise has been fulfilled" and "[i]f the solar industry ever fulfills its potential as a national energy source, the stimulus will deserve the credit."

428 Cops Will Be Retained in Florida Thanks to Stimulus Funds. "The Obama administration on Tuesday announced another round of grants for law enforcement agencies in Florida and across the country to help keep more cops on the beat during the economic downturn. Florida's share of the \$1 billion federal pot: about \$87 million to keep or hire 428 police officers around the state. 'In these hard economic times, this is a gift from heaven,' said Miami Police Chief John F. Timoney at a news conference Tuesday in Miami. Miami police will collect more than \$11 million from a grant program called Community Oriented Policing Services, commonly called COPS. Other South Florida police agencies receiving money include Fort Lauderdale, Miramar, Miami Gardens, North Miami Beach, the Seminole Tribe, Hallandale Beach, Hollywood, Lauderhill and the Monroe County Sheriff's Department." - ➤ The Three Affiliated Tribes and The Turtle Mountain Band of Chippewa Indians Will Hire New Cops With Stimulus Funds. "Citizens of northwest North Dakota should be a little safer thanks to grants made to area law enforcement agencies as part of the American Recovery and Reinvestment Act economic stimulus package.... Area agencies awarded one new officer each in addition to Ward County include Cando, McHenry County, the Three Affiliated Tribes and the Turtle Mountain Band of Chippewa Indians." - ▶ Flint Police Chief "Ecstatic" That Department Can Rehire 8 Laid Off Police Officers Using Stimulus Cash. "The Flint Police Department has been awarded \$1.4 million in federal recovery money to rehire eight laid-off police officers. Flint had asked for money to fund 50 officers but Police Chief Alvern Lock was pleased with the news Tuesday. 'I'm ecstatic,' said Lock. 'I'm not complaining at all...Lock said officers could be back on the streets as early as next week and that plans are still being finalized on how they will be deployed. The only other local agency to get federal money in Tuesday's announcement was Mott Community College with \$166,000 for one officer. Statewide, Detroit got the most officer funds with \$11 million for 50 officers." [Flint Journal, 7/28/09]
- ► Hawkeye Community College Will Hire New Instructors with Stimulus Funds. "President Greg Schmitz on Tuesday said nearly two-thirds of Hawkeye Community College's federal stimulus money will be spent on hiring instructors for this fall. The college is receiving about \$1.8 million in American Recovery and Reinvestment Act funds after state cuts reduced the 2009-10 budget by a similar amount. 'We're going to spend the majority on faculty-related expenditures,' Schmitz told the Board of Trustees. A proposed budget showed 59 percent of the total, or \$1.07 million, would pay for hiring faculty. Six full-time instructors will be hired at an estimated cost of \$420,000. One of those instructors will be for a new health care program in physical therapy assisting or occupational therapy assisting... The remaining \$645,900 to be used on faculty will pay for hiring adjunct instructors. Officials say among those new hires will be some of the 43 instructors whose jobs were eliminated last spring to help deal with a \$1.7 million state funding cut." [Waterloo Cedar Falls Courier, 7/29/09]
- Reuters Reported That The Recovery Act Has Created Or Saved 3,481 Jobs In Washington State, Leading the Nation In Job Preservation. "Washington so far has led all other states in creating or preserving jobs with federal stimulus money for infrastructure projects, according to a Reuters report this week. In its own report, the Washington state Department of Transportation said work created by stimulus-funded infrastructure projects doubled between May and June. Payroll data from state and local contractors showed 58,000 work hours on transportation projects in June, up from 29,000 in May, according to WSDOT. The state's data showed 1,811 workers had been hired in June, up from 850

the prior month. Workers earned an average of \$38 per hour. The total payroll was \$3.89 million from April through June, according to WSDOT's Web site. 'Our message to the public is that work is ramping up and that projects are underway and people are out working,' WSDOT spokeswoman Melanie Coon said. Washington is slated to get \$492 million of \$48 billion awarded to state and local transportation projects through the \$787 billion American Recovery and Reinvestment Act. Reuters, citing recent data from the U.S House of Representatives' Transportation and Infrastructure committee, reported that Washington was ahead of all states with 3,481 jobs, mostly involved with highway repair. Nationally, jobs created or saved with stimulus funding more than doubled from 21,000 to 59,000, according to Reuters." [Seattle Post-Intelligencer, 7/29/09]

> For Namaste Solar's President, The Company President Obama Visited The Day The Recovery Act Was Signed, The Recovery Act's "Promise Has Been Fulfilled", Noting "If The Solar Industry Ever Fulfills Its Potential As A National Energy Source, The Stimulus Will Deserve The Credit." "Barack Obama needed a warm-up act, somebody who could put a face on both the stimulus and the future of the American economy. Blake Jones was that guy. And so he got up on stage and explained why an unknown like him was asked to introduce the president. His voice cracked a bit as he explained that he is the president of Namaste Solar. His company had grown accustomed to torrid growth (from three to 55 employees in three years), but then the recession hit. The fourth quarter of 2008 was ugly: hiring freezes, budget cuts, the threat of layoffs. No money in the capital markets means nobody can afford to install solar systems. And no installations means no profit for Namaste, a company that had been in the black for three years running. But the stimulus, Jones said while standing in front of Obama and Joe Biden, would change all that. His boilerplate was pitch-perfect: 'Now, because of the stimulus bill that the president will sign today, our pessimistic outlook has been injected with new hope and optimism,' he said. 'This stimulus bill will immediately benefit companies like ours.' Before the bill became law, the administration had chosen him to be the final person to give voice to the bill's promise. Five months later, the promise has been fulfilled. Talking with Jones in his Boulder office is like talking to a born-again optimist. The stimulus that has beguiled and disappointed so many others has helped him find his way back. Jones patiently talked me through the stimulus' solar treatment for an hour and a half, and he couldn't say enough good things about it. Weekly Economic Recovery Success Stories Report

After Vice President Biden and Attorney General Holder announced that the Recovery Act would award \$1 billion in grants to local law enforcement agencies, police departments in twenty-four states from North Dakota to Florida reported that they will be able to hire or retain police officers.

Five states announced that they would be able to save or create jobs due to stimulus funds, including lowa where Hawkeye Community College planned to hire additional instructors. A report detailing jobs created and retained by the Recovery Act by state, found that Washington led the nation with 3,481 jobs created or saved so far.

In addition, one noteworthy story this week came out of Boulder, Colorado, where Blake Lewis, the president of Namaste Solar, the company visited by President Obama the day the Recovery Act was signed, lauded the success of the Recovery Act. Lewis, whose company is thriving under the Recovery Act, stated that the Act's "promise has been fulfilled" and "[i]f the solar industry ever fulfills its potential as a national energy source, the stimulus will deserve the credit."

428 Cops Will Be Retained in Florida Thanks to Stimulus Funds. "The Obama administration on Tuesday announced another round of grants for law enforcement agencies in Florida and across the country to help keep more cops on the beat during the economic downturn. Florida's share of the \$1 billion federal pot: about \$87 million to keep or hire 428 police officers around the state. 'In these hard economic times, this is a gift from heaven,' said Miami Police Chief John F. Timoney at a news conference Tuesday in Miami. Miami police will collect more than \$11 million from a grant program called Community Oriented Policing Services, commonly called COPS. Other South Florida police agencies receiving money include Fort Lauderdale, Miramar, Miami Gardens, North Miami Beach, the Seminole Tribe, Hallandale Beach, Hollywood, Lauderhill and the Monroe County Sheriff's Department." - ➤ The Three Affiliated Tribes and The Turtle Mountain Band of Chippewa Indians Will Hire New Cops With Stimulus Funds. "Citizens of northwest North Dakota should be a little safer thanks to grants made to area law enforcement agencies as part of the American Recovery and Reinvestment Act economic stimulus package.... Area agencies awarded one new officer each in addition to Ward County include Cando, McHenry County, the Three Affiliated Tribes and the Turtle Mountain Band of Chippewa Indians." - ➢ Flint Police Chief "Ecstatic" That Department Can Rehire 8 Laid Off Police Officers Using Stimulus Cash. "The Flint Police Department has been awarded \$1.4 million in federal recovery money to rehire eight laid-off police officers. Flint had asked for money to fund 50 officers but Police Chief Alvern Lock was pleased with the news Tuesday. 'I'm ecstatic,' said Lock. 'I'm not complaining at all...Lock said officers could be back on the streets as early as next week and that plans are still being finalized on how they will be deployed. The only other local agency to get federal money in Tuesday's announcement was Mott Community College with \$166,000 for one officer. Statewide, Detroit got the most officer funds with \$11 million for 50 officers." [Flint Journal, 7/28/09]
- ➤ Hawkeye Community College Will Hire New Instructors with Stimulus Funds. "President Greg Schmitz on Tuesday said nearly two-thirds of Hawkeye Community College's federal stimulus money will be spent on hiring instructors for this fall. The college is receiving about \$1.8 million in American Recovery and Reinvestment Act funds after state cuts reduced the 2009-10 budget by a similar amount. 'We're going to spend the majority on faculty-related expenditures,' Schmitz told the Board of Trustees. A proposed budget showed 59 percent of the total, or \$1.07 million, would pay for hiring faculty. Six full-time instructors will be hired at an estimated cost of \$420,000. One of those instructors will be for a new health care program in physical therapy assisting or occupational therapy assisting...The remaining \$645,900 to be used on faculty will pay for hiring adjunct instructors. Officials say among those new hires will be some of the 43 instructors whose jobs were eliminated last spring to help deal with a \$1.7 million state funding cut." [Waterloo Cedar Falls Courier, 7/29/09]
- Reuters Reported That The Recovery Act Has Created Or Saved 3,481 Jobs In Washington State, Leading the Nation In Job Preservation. "Washington so far has led all other states in creating or preserving jobs with federal stimulus money for infrastructure projects, according to a Reuters report this week. In its own report, the Washington state Department of Transportation said work created by stimulus-funded infrastructure projects doubled between May and June. Payroll data from state and local contractors showed 58,000 work hours on transportation projects in June, up from 29,000 in May, according to WSDOT. The state's data showed 1,811 workers had been hired in June, up from 850

the prior month. Workers earned an average of \$38 per hour. The total payroll was \$3.89 million from April through June, according to WSDOT's Web site. 'Our message to the public is that work is ramping up and that projects are underway and people are out working,' WSDOT spokeswoman Melanie Coon said. Washington is slated to get \$492 million of \$48 billion awarded to state and local transportation projects through the \$787 billion American Recovery and Reinvestment Act. Reuters, citing recent data from the U.S House of Representatives' Transportation and Infrastructure committee, reported that Washington was ahead of all states with 3,481 jobs, mostly involved with highway repair. Nationally, jobs created or saved with stimulus funding more than doubled from 21,000 to 59,000, according to Reuters." [Seattle Post-Intelligencer, 7/29/09]

> For Namaste Solar's President, The Company President Obama Visited The Day The Recovery Act Was Signed, The Recovery Act's "Promise Has Been Fulfilled", Noting "If The Solar Industry Ever Fulfills Its Potential As A National Energy Source, The Stimulus Will Deserve The Credit." "Barack Obama needed a warm-up act, somebody who could put a face on both the stimulus and the future of the American economy. Blake Jones was that guy. And so he got up on stage and explained why an unknown like him was asked to introduce the president. His voice cracked a bit as he explained that he is the president of Namaste Solar. His company had grown accustomed to torrid growth (from three to 55 employees in three years), but then the recession hit. The fourth quarter of 2008 was ugly: hiring freezes, budget cuts, the threat of layoffs. No money in the capital markets means nobody can afford to install solar systems. And no installations means no profit for Namaste, a company that had been in the black for three years running. But the stimulus. Jones said while standing in front of Obama and Joe Biden. would change all that. His boilerplate was pitch-perfect: 'Now, because of the stimulus bill that the president will sign today, our pessimistic outlook has been injected with new hope and optimism,' he said. 'This stimulus bill will immediately benefit companies like ours.' Before the bill became law, the administration had chosen him to be the final person to give voice to the bill's promise. Five months later, the promise has been fulfilled. Talking with Jones in his Boulder office is like talking to a born-again optimist. The stimulus that has beguiled and disappointed so many others has helped him find his way back. Jones patiently talked me through the stimulus' solar treatment for an hour and a half, and he couldn't say enough good things about it. If the solar industry ever fulfills its potential as a national energy source, the stimulus will deserve the credit. It could become one of the bill's chief legacies." [Slate Magazine, 7/30/09]

## WHITE HOUSE OFFICE

The Professional and Leadership Development Series continued with Valerie Jarrett speaking to a capacity audience on July 29, 2009. She addressed more than 86 young and eager staffers about her personal career journey and experiences. She spent 45 minutes taking questions. We are looking forward to welcoming Chief of Staff Rahm Emanuel as a speaker in August.

Jim Messina spoke to the interns—feedback was quite positive, as well. The theme of his talk centered around his ethos: 1) figure out what you love to do and do it; 2) your word is all you have in this town; and 3) outwork everybody. Chris Lu also met this week with a small group of Correspondence interns. We are very appreciative of the time that senior staff dedicates to these initiatives as they contribute to the development of our young professionals and overall morale.

This week we are launching an electronic newsletter for WHO staff called *WHO News*. A preview of the first issue can be viewed by clicking <u>WHO News</u>.

## White House Personnel

As part of the Work-Life Balance Initiative, White House Personnel invited representatives from LifeCare to present their program to M&A. LifeCare assists with everyday life issues at home so that employees are comfortable and at ease on the job site. It offers programs and referral services for child and elder care, physicians, education and financial aid research, and general support that can include finding local pet care, financial, and cleaning services. One of our staff is currently testing the referral service to see if she can find cheaper auto insurance as part of the vetting underway.

## **Visitors Office**

The Visitors Office provided a tour for the families of Sgt. Crowley and Dr. Gates prior to their meeting with the President. Both families met in the Library, where Professor Gates and Sgt. Crowley met first and then introduced their families to one another. After 10-15 minutes mixing pleasantly, both families were escorted through the various rooms of the residence.

## **Photo Office**

The Defense Intelligence Agency (DIA) granted our request for an additional staff FTE for the Photo Office. This enables us to hire a photo editor to ease the demands on this department. The Photo Office has created added efficiencies by utilizing Flickr Photostream. Photos we post are immediately available for anyone to view and news organizations to download for use in publications. We have 981 photos posted that have had more than 21.6 million views to date.

## **White House Operations**

Next week will be the last week of the WHO EEOB moves. We next shift our focus to the GSA project to re-carpet and paint the hallways and offices of the West and East Wings. Beginning next Wednesday, GSA will work primarily on weekends through the month of August to refurbish the main hallways in both wings. A postmaster to staff is planned.

As of Wednesday, July 29<sup>th</sup>, 64 WHO Laptops and workstations have been installed. All WHO APs are finished or scheduled by Wednesday, August 5<sup>th</sup> and DAPS by Friday, Aug 7<sup>th</sup>.

## **OFFICE OF ADMINISTRATION**

**Budget:** Based on a recent OA review, we completed \$566k of GSA rent de-obligations adding to the \$834k in OA funds that have been de-obligated since January 20th. We are in the final steps of de-obligating an additional \$275k so that between CIP (no year funds) and S+E (FY2009 funds) we will have freed \$1.6 million.

**Renovation:** The carpet and paint projects for the FLOTUS' and the Vice President's offices are complete. Staffs for both and the Vice President have expressed satisfaction.

In support of the temporary storage building project on the southeast lawn, a crane is required on-site August 1 - 2. Parking on State Place will be blocked. Major work occurring after August 3 will be coordinated for nights or weekends to minimize disruption to the State Place entrances.

The conversion of Room 430 into a presidential video conference room (serving as Room 350 during Phase III construction) is expected to be complete by September 18.
