GENERAL UPDATE

- **Supply managers in non-manufacturing industries continued to report growth in June, albeit at a slower pace than had been reported for May**, according to a survey by the Institute for Supply Management (ISM). The overall non-manufacturing index registered 53.8, down 1.6 percentage points from May. (Any figure above 50 indicates growth.) The non-manufacturing employment index decreased 0.7 percentage points to 49.7. This employment index has been close to the breakeven level of 50 since March, and passed 50 just last month for the first time since January 2008. Last week, the ISM reported that the manufacturing supply index edged down 3.5 percentage points to 56.2, a reading that also indicates continued growth but at a slower pace.



- **Enrollment in Medicare Advantage (MA) plans increased in June by approximately 29,000 to 11.5 million, the highest level ever, but fell as a fraction of overall Medicare enrollment to 24.7 percent**, according to new data from the Centers for Medicare and Medicaid Services. MA enrollment shares vary significantly by state. The shares are highest in Hawaii and Oregon (42.9 and 42.2 percent, respectively) and lowest in Alaska and Delaware (0.6 and 3.6 percent, respectively).

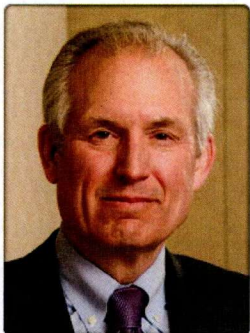
- While risk appetite generally rebounded across a range of asset classes today, U.S. equity markets continued to underperform, with the S&P500 up only 0.5% versus a 2.8% rise on a broad European benchmark equity index. Treasury yields also declined as many market participants cited burgeoning concerns over the U.S. economic growth outlook. Since Friday's weaker-than-expected employment report, several major investment banks have become more pessimistic about the outlook for U.S. and global growth. Market participants are also increasingly focusing on whether Congress will extend U.S. unemployment benefits, which will have important implications for growth. Today's service sector index showed lower than expected growth during June.
- Since May 1, the S&P 500 index has declined more than 13%, led by cyclical sectors—those that are most sensitive to economic growth expectations. For example, financial institutions, building materials, industrials, and energy stocks have declined between 16 and 17%, while sectors where spending is less discretionary (consumer staple, utilities, and health care) have declined only 6 to 9%. This points to a fundamental shift in investor positioning, on expectations that the pace of the U.S. recovery may be slowing. Consistent with that, options market investors are paying a large premium to protect against the risk of a sharp decline in equity markets.
- The Shanghai Composite equity index increased 1.9%, as the Chinese government will initiate \$100 billion dollars of major infrastructure projects. Separately, Chinese state bank Agricultural Bank of China priced an initial public offering (IPO) that is reportedly on track to reach \$22 billion, which would be the largest IPO on record. Reports note that the deal, which was priced in the middle of the firm's target range, demonstrates investor confidence. The pricing of the deal took place after Chinese equity markets closed, and some analysts note that the large increase in market capitalization may weigh on the Shanghai stock market tomorrow.

European Markets: European equity indices rose between 2 and 3.6% and financial sector shares outperformed, rising by about 4%. Sentiment was supported by reports that Spain's 10-government bond syndication has been well-received by investors. Spain reportedly received stronger demand from international accounts than from domestic banks, which was viewed positively by market participants. Separately, Spanish Finance Minister Salgado indicated that the stress tests for Spanish banks will cover 95% of Spanish financial institutions, and would soon be published.

Foreign Exchange: The dollar continued to weaken against the euro, depreciating 0.6% on the day. Contacts noted that the euro has become increasingly attractive compared to the dollar as short-term euro-denominated money market rates have risen over the past few trading sessions while comparable dollar-denominated rates have been relatively unchanged. Separately, the yen strengthened 0.3% versus the dollar amid reports that China had increased its exposure to Japanese government bonds.

BP: Shares of BP rose by 3.7% and 7.5% in U.K. and U.S. trading, respectively. There were widespread reports that BP is courting sovereign wealth funds for new capital and/or considering a new equity share offering. BP did not confirm the reports.

Progress Report on the National Export Initiative

- The President provided a progress report today on the National Export Initiative, which aims to create jobs and improve the economy for all Americans. The NEI has five objectives, all of which we have made progress on since the President announced this effort in his State of the Union Address:
 - *Improved advocacy efforts on behalf of U.S. exporters:* The Department of Commerce has coordinated 18 trade missions with over 160 companies participating in 24 countries.
 - *Increased access to export financing:* Ex-Im has more than doubled its loans to support American exporters from the same period last year, helping to support nearly 110,000 jobs.
 - *Reinforced efforts to remove barriers to trade:* In March, the United States reached an agreement with China to reopen the Chinese market to U.S. pork and pork products. In June, the United States agreed with Russia to reopen the Russian market to U.S. poultry exports. These steps are worth more than \$1 billion.
 - *Enforcement of trade rules:* Last week the WTO ruled that European government subsidies subsidized Airbus's large civil aircraft. This ruling is expected to sustain and even restore jobs to American aerospace workers by leveling the playing field for the U.S. aerospace industry.
 - *International promotion of policies leading to strong, sustainable and balanced economic growth:* These last 18 months have been the most effective period of international economic cooperation in generations with global growth replacing economic contraction.
- As a result of these policies, and a global economic rebound, exports in the first four months of 2010 grew almost 17 percent from the same period last year. ***This puts the U.S. on track to reach the President's goal of doubling exports and supporting several million new jobs over five years.***
- The President met yesterday with his Export Promotion Cabinet, which reported on its successes in improving the international climate for U.S. exports.
- And this morning, the President announced the formation and membership of his Export Council, which includes a group of business and labor leaders who will offer advice on how to promote U.S. exports, jobs, and growth, including James McNerney, Chairman, President and CEO, the Boeing Company.

The role of exports in supporting jobs and growth

Exports have been a key driver of jobs and growth

- In 2008, exports supported 10.3 million jobs, accounted for 6.9 percent of total U.S. employment and represented a record 12.7 percent of the Gross Domestic Product (GDP). These jobs are higher paying on average.
- Fully 36 percent of all manufacturing jobs are tied to exports and 19 percent of all agriculture employment. Exports from the services sector supported 2.8 million jobs.
- Increasing exports will support millions of additional jobs in a deficit friendly manner.

The goal of doubling exports is on track

- The Council of Economic Advisers' analysis shows that over the past nine months, the increase in US exports contributed more than one percentage point to the US growth rate. During our recovery, exports have contributed as much as domestic consumption to our growth.
- Exports are playing a critical role in supporting jobs and creating prosperity in America.

Our National Export Initiative

Export growth does not just happen on its own.

- With the President's National Export Initiative (NEI), the Administration committed to use all of the tools at its disposal to help American exporters grow their markets and support additional jobs. America's businesses are the engine of growth and exports, and we will do all we can to support their efforts.
- The NEI has five components, improved advocacy efforts on behalf of U.S. exporters, increased access to export financing, reinforced efforts to remove barriers to trade, enforcement of trade rules, and the international promotion of policies leading to strong, sustainable and balanced economic growth.

The Administration has stepped up advocacy and boosted export finance

- Since February, the Department of Commerce has coordinated an unprecedented 18 trade missions with over 160 companies participating in 24 countries. Most recently, Secretary Locke and USTDA Director Zak led 46 U.S. business executives on a clean energy trade mission to China and Indonesia.
- The Department of Commerce's Advocacy Center has assisted U.S. companies competing for international contracts and other U.S. export opportunities, supporting \$11.4 billion in U.S. export content, or an estimated 70,000 jobs. There are over 380 more active cases in the pipeline.
- Secretary Clinton held a major commercial event in Shanghai on May 23rd at the Boeing Maintenance Facility, which included a roundtable with corporations.

- The Export-Import Bank (Ex-Im) has more than doubled its loan authorizations (deals) in the first half of the current fiscal year over the same period last year:
 - From \$5.9 billion in FY '09 to \$13.2 billion in FY '10.
 - Small business authorizations have increased from \$1.7 billion to \$2.3 billion.
 - Estimated number of US jobs supported by Ex-Im financing has almost doubled from 61,000 to 109,000.

Opening markets for our companies and workers

- The United States' competitors for export markets are not sitting still and the Administration is taking active steps to open foreign markets to our goods and services.
- In March, Secretary Vilsack and USTR Kirk announced that the United States and China have reached an agreement to reopen the Chinese market to U.S. pork and pork products. Twenty percent of U.S. pork production was exported in 2009, supporting American hog producers and agriculture jobs at home. Prior to H1N1 trade constraints, U.S. pork and pork variety meats exports to China were valued at nearly \$275 million in 2008.
- The United States and Russia agreed during the recent visit by President Medvedev to reopen the Russian market to U.S. poultry exports, which has been a \$760 million market for U.S. products. Also announced during the visit was the sale of 50 Boeing airplanes worth an estimated \$4.0 billion that had been advocated for by the Administration.
- Last week President Obama announced that he is instructing USTR Kirk to begin discussions with his Korean counterpart to resolve outstanding issues with the Korean Free Trade Agreement. The Korean FTA would increase goods exports by an estimated \$10-11 billion, which would support an estimated 70,000 jobs, and the gains from the agreement could significantly exceed that estimate when reductions in non-tariff barriers and increases in services exports are included.
- USTR has released two new reports on sanitary and phytosanitary barriers and technical barriers to trade that harm the ability of America's agricultural producers and manufacturers to export around the world. These reports will help focus U.S. efforts on opening new markets for U.S. exporters.

Enforcing our agreements

- Where American producers are facing unfair trading practices, the United States is using all of its enforcement tools to level the playing field for U.S. exporters and promote jobs for Americans.
- Last week the WTO ruled in favor of the U.S. on a case that found that European government subsidies worth billions have been used to subsidize the creation of every model of large civil aircraft produced by Airbus, which has damaged Boeing and its workers. This ruling is expected to sustain and even restore jobs to American aerospace workers by leveling the playing field for the U.S. aerospace industry.

Promoting strong, sustainable and balanced growth

- The Administration is not only focused on improving U.S. performance in individual markets and leveling the playing field for U.S. producers, but in creating conditions for strong global growth that support exports and jobs in the United States.

- Secretary Geithner is promoting balanced and strong growth in the global economy through the G-20 process. These last 18 months have been the most effective period of international economic cooperation in generations. Globally, economic contraction has given way to economic growth, and emerging economies in particular are seeing impressive growth. Our efforts to support exports positions America to take advantage of global recovery as it progresses.

Export Control System Reform

- Efforts continue on the recently announced reform program that will enhance national security by focusing on the enforcement of strict controls around the export of the most critical technologies and products. This reform will strengthen the competitiveness of key manufacturing industries in the U.S. by streamlining the regulations that apply to their exports.

How we organize our work

Today, the President introduced his Export Council (PEC), a group of business and labor leaders who will offer advice from outside of the Administration. The business leaders come from companies with tremendous success in increasing exports for their products. The Chair and Co-chair of the PEC are James McNerney, Chairman, President and CEO, the Boeing Company and Ursula Burns, CEO, Xerox, who will serve along with 18 other Presidential appointees as appointees from the Administration, the Senate and the House.

The President also announced plans to hold his Export Promotion Cabinet meetings quarterly to ensure the NEI is properly implemented and pursued. The Export Promotion Cabinet will be providing its 180 day report to the President in September.

The Administration plans to conduct 8 more trade missions over the next three months. On July 16, Secretaries Clinton and Locke plan to host a business roundtable with the CEOs of multinational corporations and small and medium-sized enterprises to discuss barriers to U.S. exports.

PURPOSE: Inform Cory Etchberger that YOU will award the Medal of Honor (posthumously) to his father. (Chief Master Sergeant Richard Etchberger, USAF)

You reviewed and approved the awarding of the Medal of Honor to Sergeant Etchberger on May 6, 2010. Currently, you have two additional MoH packages in for consideration and your approval.

TALKING POINTS:

- Based on the recommendations of the Secretary of the Air Force and the Secretary of Defense, I have approved the award of the Medal of Honor to Chief Master Sergeant Richard L. Etchberger, U.S. Air Force, for conspicuous gallantry.
- It is my great honor to inform you that your father will posthumously receive the Medal of Honor at a ceremony here at the White House.
- I am humbled by your father's sacrifice and his example of selfless service.
- I look forward to hosting you here at the White House for the medal presentation.
- My staff will be in touch to set up a time for the award ceremony.

PERSONAL BACKGROUND:

Chief Master Sergeant Richard Etchberger's widow, Katherine Etchberger, died in September, 1994

Chief Master Sergeant Richard Etchberger had three sons: Steve Wilson, Richard Etchberger, Jr, and Cory Etchberger.

Cory Etchberger serves as the primary family representative. He was nine years old when his mother took the phone call saying that his father had died in action. Cory Etchberger has collected much of his father's past. He keeps his father's medals and the tri-folded flag that draped his casket in an oak display case at the top of his second-floor landing. He keeps scrapbooks of all of his father's military papers, photographs of himself and his family at the Pentagon receiving his dad's Air Force Cross.

ADDITIONAL INFORMATION:

Chief Master Sergeant Richard L. Etchberger was originally awarded the Air Force Cross for his heroic action on March 11, 1968. The details of his unit's location and activities that initially prevented the award of the Medal of Honor have been declassified in the years since his death. After an additional review by the Air Force Decoration Board, the upgrade of his Air Force Cross to the Medal of Honor is recommended by the Air Force Decoration Board and supported by the Chairman, Joint Chiefs of Staff, Secretary of the Air Force and the Secretary of Defense.

THE MEDAL OF HONOR:

The Medal of Honor is awarded to a member of the Armed Forces who distinguishes themselves conspicuously by gallantry above and beyond the call of duty while:

- engaged in an action against an enemy of the United States;
- engaged in military operations involving conflict with an opposing foreign force; or
- serving with friendly foreign forces engaged in an armed conflict against an opposing armed force in which the United States is not a belligerent party.

The meritorious conduct must involve great personal bravery or self-sacrifice so conspicuous as to clearly distinguish the individual above his or her comrades and must have involved risk of life. There must be incontestable proof of the performance of the meritorious conduct, and each recommendation for the award must be considered on the standard of extraordinary merit.

ACTION FROM WHICH THE MEDAL OF HONOR WAS EARNED:

Chief Master Sergeant Richard L. Etchberger distinguished himself by extraordinary heroism on 11 March 1968 in the country of Laos, while assigned as Ground Radar Superintendent, Detachment 1, 1043d Radar Evaluation Squadron. On that date, Chief Etchberger and his team of technicians were manning a top secret defensive position at Lima Site 85 when the base was overrun by an enemy ground force. Receiving sustained and withering heavy artillery attacks directly upon his unit's position, Chief Etchberger's entire crew lay dead or severely wounded. Despite having received little or no combat training, Chief Etchberger single-handedly held off the enemy with an M-16, while simultaneously directing air strikes into the area and calling for

air rescue. Because of his fierce defense and heroic and selfless actions, he was able to deny the enemy access to his position and save the lives of his remaining crew. With the arrival of the rescue aircraft, Chief Etchberger, without hesitation, once again deliberately risked his own life numerous times, exposing himself to heavy enemy fire in order to place his three surviving wounded comrades into rescue slings hanging from the hovering helicopter waiting to airlift them to safety. With his remaining crew safely aboard, Chief Etchberger finally climbed into an evacuation sling himself, only to be fatally wounded by enemy ground fire as he was being raised into the aircraft. Chief Etchberger's bravery and determination in the face of persistent enemy fire and overwhelming odds are in keeping with the highest standards of performance and traditions of military service. Chief Etchberger's gallantry, self-sacrifice, and profound concern for his fellowmen at risk of his life, above and beyond the call of duty, reflect the highest credit upon himself and the United States Air Force.

Ronald “Ron” Medford

Ron is currently the Deputy Administrator at the Nation Highway Traffic Safety Administration (NHTSA) at the Department of Transportation. Prior to becoming an Obama Appointee in January 2010, Ron was a Federal employee for 17 years. Michael Eric Dyson

Michael Eric Dyson is a professor, commentator and "hip-hop intellectual" who has written 16 books on race, politics, and the African-American experience. Dyson's background is unusual for a scholar: a Detroit gang member and unwed father in his late teens, he turned himself around and became an ordained Baptist minister at age 21. He earned a bachelor's degree from Carson-Newman College in 1982, then went on to acquire a master's (1991) and a PhD (1993) from Princeton. His books *Making Malcolm: The Myth and Meaning of Malcolm X* (1994) and *Between God and Gangsta Rap* (1995) established him as a serious contributor to African American thought, and he became a sought-after commentator on radio and TV. He tangled with comedian Bill Cosby in *Is Bill Cosby Right?* (2006), and his 2007 book *Know What I Mean: Reflections on Hip-Hop* came with an introduction by rapper Jay-Z. Dyson has taught at a long string of schools: the Chicago Theological Seminary (1989-92), Brown University (1993-95), the University of North Carolina (1995-97), Columbia University (1997-99), DePaul (as the first Ida B. Wells-Barnett University Professor, 1999-2002), the University of Pennsylvania (as the Avalon Professor of Humanities, 2002-07) and at Georgetown University (currently teaching English, theology, and African American studies). His biographies of leading black figures include *Mercy, Mercy Me: The Art, Love and Demons of Marvin Gaye* (2004) and *April 4, 1968*, his 2008 reflection on the death of Martin Luther King.

In addition to his writing, Dyson now hosts, "The Michael Eric Dyson Show" a daily program airing weekly in syndication through the NPR and Public Radio International networks.

BACKGROUND:

Bill Lucy, 76, retired last week as Secretary-Treasurer of AFSCME, a position he has held since 1972. Lucy also founded and served as President of the Coalition of Black Trade Unionists. Lucy has worked on social justice issues most of his adult life, including collaborating with Dr. King on the Memphis sanitation workers strike and taking a lead role in the anti-apartheid movement. Lucy helped lead the efforts within AFSCME during the primaries to mitigate the union's endorsement, and played a quiet role in marshalling African American union support behind YOU.

Lucy is succeeded at AFSCME by Lee Saunders, a close ally of Gerald McEntee. Saunders won after a competitive election in which Lucy, among others, backed another candidate; the election was significant because the winner has the inside edge to succeed McEntee when he eventually vacates the presidency. Saunders has often played a moderating voice between the White House and McEntee.
