COMMUNICATIONS ACTIVITIES

Public Service Announcement on Bullying

- The Vice President and Dr. Biden will tape a joint Public Service Announcement on bullying for the Discovery Channel. The PSA will be played at four town halls on bullying prevention across the country, beginning May 9th.

DC Volunteer Lawyers Project

- The Vice President will deliver remarks at an event for the DC Volunteer Lawyers Project and his remarks will be pooled press.

World Food Program USA's "Live Below the Line" Challenge

- Dr. Biden will give opening remarks on a conference call with bloggers for the World Food Program USA's "Live Below the Line" challenge. Also joining the call are World Food Program USA Board Chair Hunter Biden and World Food Program USA President & CEO Rick Leach. Live Below the Line is an initiative of the Global Poverty Project, an education and campaigning organization whose mission is to increase the number and effectiveness of people taking action against extreme poverty.

Commencement Message

- Dr. Biden will tape a commencement message for the 2013 graduating class of David Glogow Farragut High School in the U.S naval station in Rota, Spain.

FLOTUS

- The First Lady's office will announce that the First Lady is doing a book signing next week for her book "American Grown."

RAPID RESPONSE/RESEARCH

- We continue to monitor and compile reporting on impacts of sequestration and congressional reaction to those impacts
- We are researching oversight issues to assist the communications department.
- We are researching health care implementation to assist the communications department.

CABINET ACTIVITIES

Activities of Note:

- **Veterans Backlog:** Secretary Shinseki will kick-off a tour of regional offices -- Milwaukee, WI; Cleveland, OH; Hartford and West Haven, CT; and New Orleans, LA -- where the new electronic records software has been deployed. He will meet with employees and leadership to demonstrate the agencies' commitment eliminate the backlog and to continue to serve Veterans. Secretary Shinseki will also visit the VA Center of Excellence in Primary Care Education at the West Haven VA Medical Center.
- **Education:** Secretary Duncan will participate in an Equity and Excellence Commission town hall with Rep. Honda and members of the Equity and Excellence Commission at Fremont High School in the San Francisco, CA area. Following that event, Secretary Duncan will participate in New Schools Venture Fund's annual summit. At the summit, he will participate in a conversation to discuss the Administration's second term education agenda and engage in a question-and-answer session moderated by Laurene Powell Jobs.
- **Human Trafficking:** Secretary Sebelius will give a keynote address at the Johns Hopkins University Bloomberg School of Health Symposium on "Meeting the Needs of Child Trafficking Survivors." Later in the day, CDC staff will present "The Public Health Implications of Child Sex Trafficking."
- **Everglades Restoration:** Secretary Jewell will travel to Florida to visit the Everglades and underscore the Administration's ongoing commitment to its restoration. Secretary Jewell will meet with stakeholders and departmental employees. Jewell will participate in two open press airboat tours.
- **Trade:** Acting USTR Marantis will do a live TV interview for CNBC Asia's *Squawk Box* regarding the release of the Special 301 Report to Congress. The Special 301 Report is an annual review of the state of intellectual property rights (IPR) protection and enforcement in trading partners around the world. Also tomorrow, Acting USTR Marantis will give remarks and take questions from the audience at an event hosted by the Global Business Dialogue.

Other Notable Events:

- **USDA:** Secretary Vilsack will highlight improvements to school nutrition in New Orleans, LA. This will be open press.
- **Commerce:** Deputy Secretary Blank will deliver opening remarks to the Civil Nuclear Trade Advisory Committee (CINTAC) at its inaugural meeting in Washington, DC. CINTAC is composed of 39 newly appointed senior executives across the U.S. nuclear supply chain and

advises the Secretary of Commerce on policy issues impacting the global competitiveness of the U.S. civil nuclear industry.

- **DoD:** Secretary of Defense Chuck Hagel will host an honor cordon to welcome Columbia's Minister of Juan Carlos Pinzonto the Pentagon. This will be open press.
- **GSA:** GSA Acting Administrator Dan Tangherlini will be participating in "the Morning Fix," organized by the DC Chamber of Commerce to speak about GSA and its impact on the Washington DC community. He will be addressing approximately 100 business leaders from the area.
- **HHS:** Secretary Sebelius will deliver remarks at *We the People*, a health care symposium hosted by AltaMed Health Services and the Latino Coalition.
- **DOJ:** Attorney General Eric Holder will deliver remarks at the Justice Department Law Day Commemoration in the Department's Great Hall. This event is open to the press.
- **DOT:** Secretary LaHood and Federal Motor Carrier Safety Administrator Anne Ferro will hold a press conference to kick off national moving month. The Secretary will highlight steps the Administration has taken to protect consumers from fraudulent movers.

Mel Watt

Melvin "Mel" Watt (D-NC) has been a member of the U.S. House of Representatives since 1993. During his twenty years in Congress, Rep. Watt has held senior positions on the House Financial Services and House Judiciary Committees. From 2005 to 2006, Rep. Watt served as Chairman of the Congressional Black Caucus. Before his election to the House, Rep. Watt served one term in the North Carolina State Senate and was the managing attorney at the law firm of Chambers, Stein, Ferguson, Watt, Wallas & Adkins. Watt received a B.S. from the University of North Carolina at Chapel Hill (1967) and a J.D. from Yale Law School (1970).

Thomas Wheeler

Thomas Wheeler is a Managing Director at Core Capital Partners, a venture capital firm investing in information technology, communications, digital media, and technology-enabled services. He has held this position since 2005. Prior to joining Core Capital Partners, Mr. Wheeler served as CEO of the Cellular

Telecommunications & Internet Association from 1992 to 2004. Between 1984 and 1992, Mr. Wheeler started and helped start multiple technology-based companies. Prior to that, from 1979 to 1984, Mr. Wheeler was CEO of the National Cable Television Association. He currently serves on YOUR Intelligence Advisory Board and is Chairman of the FCC's Technology Advisory Council. Mr. Wheeler previously served as Chairman of the UN Foundation's mHealth Alliance, as Chairman of the Foundation for the National Archives, and as a board member of PBS. In 2009, he led the Obama-Biden Transition Project's Agency Review Working Group for the science, technology, space and arts agencies. Mr. Wheeler received a BSc. from The Ohio State University.
