We are at our best when we recognize our common humanity, set an example of trust and responsibility for our children, and honor the sacrifices of our bravest by coming together to be better.





Message: Dear Mr President,

My name is Patrick Chilton. I am a police officer with the NYPD assigned to the Brooklyn North Evidence Collection Team. I have been a member of the greatest police department in the world and the law enforcement community for eleven years as of 11 July 2016.

I voted for you in 2012 because I thought you did a good job as a leader. Some of your policies I agreed with and some I did not, and some I had no interests in, but I thought you were a good leader. As a young police officer, still relatively new to the job in 2009, I was surprised and impressed with the meeting you had with Mr. Henry Louis Gates and Sgt. James Crowley. I was happy that you were trying to get two people, each with conflicting views of an incident, to try to understand what the other person saw and empathize with each other. The beer was the cherry on top.

My heart hurts for my brothers and sisters in law enforcement across the country who have made the ultimate sacrifice for the communities they protect. What happened in Dallas is unprecedented and as I write this letter to you I think of my family. I think of my wife of seven years, Janice, who is mourning for officers' widows and families again. I think about my parents who are worried for their children who have answered the calling to protect the flock. I mainly think of my sons. My five year old Tyler and my three year old Colin who everyday tell me they love me and want to be just like me when they grow up. I'm glad that they just want to watch cartoons so they can't see the news and hear the stories.

There is no way to solve everything overnight, but nothing can be solved without a leader. A leader who can bring two people together, each with conflicting views, to try to understand and empathize with each other.
